Info 7.2 Presentation of annual tax levy and resolution Superintendent Alexander presented the 2015 Tax Levy and Resolution. It was explained that the Levy this year is showing a higher percentage increase in anticipation of mandatory Tax Caps. The required announcement in the Pawnee Post will show an increase of 11.42%, which is misleading because the Levy request is compared to the actual extension. The reality is that the actual tax rate should not increase drastically unless the equalized assessed value of the District decreases. Pawnee has never passed a referendum but has not been restricted by Tax Caps in the past. With the passing of mandatory Tax Caps, Pension funding issues, and the continued decrease in State funding, Pawnee's ability to continue to provide a quality education is further jeopardized.

November 16, 2015 SCHOOL BOARD REPORT SUPERINTENDENT REPORT

Good News- I would like to congratulate Stacie Roscetti. Stacie applied for the John Lowe Education Grant for October 2015, through the Illinois Educators Credit Union. I would like to congratulate Stacie for her effort in obtaining this grant. She is using it to add a computer to her classroom. Good Job Mrs. Roscetti!

1. **Building issues:** Water backed up through the drains in the high school locker rooms. Custodial staff tried plunging toilets and using drain remover to clear the clog. This did not work. Plumbers came and put a camera down the pipe and ran an electric

eel 120 feet through the pipes. The flow of water resumed. It was determined that the pipes leading from the clean out toward the pipes leading out of the building are flat. They do not have a lot of fall. This could be causing some of the backup if there is multiple use of water.

2. Legislative update: Budget is still held hostage by politics. The education budget that was passed has categorical payments at the 92% level. Superintendents are being told to not count on that %. Last year we were told it would be 89% and it was lowered.
 3. State Superintendent- Dr, Smith's office release figures on state mandates and funding.

- Since 2009, public schools have received \$3.7 billion less than they should have

- Since 2009, 130 statutes have resulted in 200 new or revised mandates Dr. Smith's goal is schools to be fully funded with mandate relief.

4. **Roe Facilities Visit-** Lyle Wind did his walk through. I have included his report. Many of the areas needed addressed have been addressed. Violations are minor. Most have been addressed. The rest will be addressed throughout the year.

5. **Carbon Monoxide Detectors-** Last year North Mac schools had a carbon monoxide leak. The day it happened, I sent Scott Day to buy detectors. We have several throughout the building. January 1, 2016 law mandates schools have detectors in schools. We were told household detectors would meet the law. Now the ROE is passing information to schools that may not be the case. Lyle Wind is looking into this. If we have to have detectors tied to the fire panel, we do not have room and would have to install another fire panel in the building.
