

Creating and Sustaining a Culture of High Expectations





Board Report December 2024/25 Technology Director, Brandon Goodall

- Renewed VMware security certificates
 - reestablished vCenter connectivity, and resolved an issue that resulted in security certificate expiration
- Setup back-up drives for vCenter server
 - This step should have been competed with the installation of the server infrastructure. vCenter now backups and updates properly, and should be another layer of protection against security certificate expiration and exploitation.
- Commenced initial stages for recovering the district's Microsoft Business account.
 - This information was lost years ago, and is a barrier to the District's Microsoft products. Licenses for servers, operating systems, software and updates are all lost with this account.
 - I'm told the process will be long and tedious without cooperation from the previous tech administrator. But considering the sleuthing I had to do on my own to simply find the name of the account, it is clear the best use of my efforts will be in pursuing resolution alone.
- Replaced a faulty transceiver on a vital switch.
 - Assessed all transceivers in preparation for VoIP switchover
- Met with the Americall representative
 - Reviwed the functionality of the Grandstream phone system
 - began the porting process
 - Had the district conract with Comcast assessed
- Began switch upgrades in preparation for VoIP switchover
 - Some sites in the building where the phone cabling terminates are struggling with capacity. Switch upgrades and relocations are needed. Those can be accommodated, but the building is reaching capacity for network needs.
