Scott Day reported: Scott gave a brief report to the Board of the ongoing projects in the building.

Leanne Gehrs reported: Mrs. Gehrs gave a summary to the Board of student courses and classroom breakdown.

Erin Snodgrass reported: Mrs. Snodgrass gave an update to the Board on SASED enrollment numbers in the District. Pawnee is at 24.9% in special education enrollment. That does not include students with 504 plans or MTSS supports. The average State enrollment is 15%. At present, Pawnee has 1 SASED Administrator, 1 Psychologist and 1 Social Worker that come to Pawnee 3 days per week. Pawnee has OT/PT 1 day per week. 19 Paraprofessionals are used to help with the SASED students.

Corey Reynolds reported: Officer Reynolds gave a brief report to the Board regarding Centegix security system. He believes it would be useful to incorporate this program into the District.

Brandon Goodall reported: Mr. Goodall gave a brief report to corroborate with Officer Reynolds' report on the Centegix security system. He also reported to the Board that the current phone system will be obsolete as of September 30th.

AD Kirby reported: JH Softball ended their season with a 6-2 conference record. JH Baseball ended their season with a 4-2 conference record. They were seeded 2 in the Auburn Regional. They play on September 25th in the Semi-Finals of the Regional. Football is currently 2-0 and they play Kincaid on September 19th. Mini Cheer will perform at halftime of the September 17th Football game. They have 75 students participating. The HS Cheerleading squad will participate in the Pep Rally Pop Quiz with 99.7 The Mix on September 13th. JH Girls' Basketball had an interest meeting on September 12th. They had 21 students attend. HS Volleyball is off to a 3-4 JV & Varsity start. The Freshman/Sophomore Tournament is September 14th. 8 teams are involved.

Principal Hennemann reported: Teacher evaluations have started. State IAR test results are back and the following students exceed in Reading: Remington Arthur, Miranda Corrie, Josie Ellis, Raegan King, Harlie Leach, Bo Mosely, Elizabeth Craft, Lance Megginson, Layton Polistina, Charlotte Wessel and Penelope Wessel. Teachers have wrapped up benchmarking data for math and reading. Overall, the results are good. Parents were contacted and intervention times have started. They will continue to focus on reading and math improvement.

Principal Goodall reported: Certified teachers being evaluated this year have already scheduled preconference, observation and post-conference dates for first semester. GCN trainings are being completed by staff. LLCC Workforce Expo will be on September 19th. CACC field trip is October 2nd. The FFA National Convention in Indianapolis is scheduled for October 23-25. Winter Concert for Band & Chorus is scheduled for December 16th.
